 3. The cost of the hire is at the discretion of Drayton St Leonard Parish Council.
 4. Damage to the tent(s), once hired, will be the responsibility of the Hirer who will be charged a sum to the full cost of rectification of such damage.
 5. On collection if components of the Tent(s) are found to be damaged or missing, the Hirer must notify Drayton St Leonard Parish Council of such damage or missing component(s) immediately or they may be liable for the cost of replacing such damaged or missing component(s).
 6. If the tent(s) are used in inclement weather they must be returned dry.
 7. Drayton St Leonard Parish Council's insurance policy does not cover any liability associated with the use of the tent(s). The hirer is therefore required to indemnify Drayton St Leonard Parish Council for injury to persons or loss or damage to property by adequate 3rd Party Liability Insurance for the event for which the tent(s) is hired. Drayton St Leonard Parish Council may request sight of evidence of such coverage prior to hiring the tent(s) to the hirer.
 8. Drayton St Leonard Parish Council reserves the right to charge a cancellation/administration fee of £30 per tent.
 9. Drayton St Leonard Parish Council reserves the right to refuse to hire out the tent(s) for any reason whatsoever.
 10. The tent(s) are to remain Non-smoking areas at all times.
